IMPORTANT CONDITIONS OF PURCHASE:

1. The Falls Creek Loading Zone pass entitles the nominated vehicle to resort entry at Falls Creek Alpine Resort during the Declared Snow Season for the relevant year for the sole purpose of delivering or collecting freight items.
2. Vehicles issued with a Loading Zone pass may park in designated loading zone or staging areas within the Resort for periods up to the times nominated on loading zone parking bay signs. Under no circumstances does this pass allow the vehicle to be parked and left unattended.
3. Loading Zone passes relate to a specific vehicle. The registration number on the pass must not be altered. The pass is not transferable and if a breach of this condition is observed the pass may be withdrawn. The pass must be permanently affixed to the nominated vehicle immediately after issue. The pass must be clearly visible and affixed to the right hand bottom corner of the front windscreen.
4. Where a vehicle with a Falls Creek Loading Zone pass is sold, damaged or the windscreen broken, the pass must be removed and the parts (especially the pass number) returned to Falls Creek Resort Management for issue of a replacement. Passes are not subject to a refund in such an event. A replacement pass will only be issued to a vehicle registered in the same name as the original pass and proof of ownership via registration papers must be produced. A replacement fee of \$30.00 will apply.
5. All signs must be observed at all times.
6. Vehicles must not be left in any position that would cause an obstruction.
7. Any relevant conditions of The Alpine Resorts (Management) Regulations 2009 or Falls Creek Alpine Resorts Management Board policies, as varied from time to time, must be observed at all times.
8. Personal Information collected from your Loading Zone pass application form is used for reference purposes only. It is not provided or available to any other party.
9. By accepting this pass, you acknowledge that you have read and agree to abide by the above conditions. Furthermore, you acknowledge that Falls Creek Resort Management (including its servants and agents) will not be liable for any loss or damage caused to any vehicle, or anything in the vehicle except where caused by its (or its servants and agents) negligence.
